Sandy Wong, Executive Council, reported that the SMCEL JPA has submitted an application to the California Transportation Commission (CTC) for toll authority. At its regular meeting on August 14, 2019, the CTC unanimously approved the application. Ms. Wong also provided an update on the on-going process to select a consulting firm to act as the Policy/Program Manager for the SMCEL JPA. Interviews have been conducted and the next step is to negotiate with the highest ranked proposer based on the interview panel's recommendation. Staff aims to present a contract to the Board for approval at the next meeting.

b) Review and approval of Resolution SMCEL 19-04 authorizing the four-party Cooperative Agreement between the San Mateo County Express Lanes Joint Power Authority (SMCEL-JPA), the City/ County Association of Governments of San Mateo County (C/CAG), the San Mateo County Transportation Authority (TA), and the Bay Area Infrastructure Financing Authority (BAIFA) regarding BAIFA's expenditure of \$3 million on toll system design for the San Mateo County Express Lanes.

APPROVED

Sandy Wong, Executive Council, explained the four-party agreement is currently under final review by legal counsels from each of the four agencies, thus, marked as "draft" in the meeting packet. Staff recommends the Board to approve Resolution SMCEL 19-04 authorizing the Chair to execute said agreement upon final review, provided the final agreement is substantially the same as the draft provided to the Board at this meeting.

Since the total of \$514 million project cost is being spent in many different components, Director Beach requested staff to provide information that tracks the different buckets of money for this project.

Director Freschet noted there were two typos in Resolution SMCEL 19-04.

Director Papan **MOVED** to approve Resolution SMCEL 19-04, Director Freschet **SECONDED**, with correction to the typo errors. Roll call was taken. **MOTION CARRIED UNANIMOUSLY 5-0-0**

RECOMMENDATION

That the SMCEL-JPA Board of Directors review and approve Resolution SMCEL 19-05 authorizing the Chair to execute a two-year agreement with HNTB Corporation for Policy/Program Management Services for a total amount not to exceed \$1,381,716.

FISCAL IMPACT

The total amount for this agreement is up to \$1,381,716 for two calendar years, effective November 1, 2019 and ending October 31, 2021. However, since the SMCEL-JPA adopts budget on an annual basis, expenditures beyond the current budget year will be subjected to future budget approval.

SOURCE OF FUNDS

As an agency with no current operating revenue, the SMCEL-JPA anticipates that both SMCTA and C/CAG will loan funds to cover its initial operating budget. At present, loan agreements with SMCTA and C/CAG for fiscal year 2019-2020 are being prepared for SMCEL-JPA Board approval at the November 8, 2019 Board meeting.

BACKGROUND

On April 11, 2019 and May 2, 2019 the City/County Association of Governments ("C/CAG") Board and the San Mateo County Transportation Authority ("SMCTA") Board, respectively approved the Joint Exercise of Powers Agreement (JEPA) for the Express Lanes Joint Powers Authority (JPA). The JEPA created the JPA pursuant to the California Joint Exercise of Powers Act to oversee the operations and administration of the San Mateo 101 Express Lanes Project, and to jointly exercise ownership rights over the express lanes.

On June 13, 2019 and July 11, 2019 the C/CAG Board and SMCTA Board respectively, approved the First Amended and Restated Joint Exercise of Powers Agreement officially changing the name of the

JPA from Express Lanes Joint Powers Authority to San Mateo County Express Lanes Joint Powers Authority. The purpose is to more plainly reflect that the JPA is a San Mateo County entity, which could be important for securing financing and marketing the Express Lanes Project.

Per the JEPA, SMCEL-JPA will retain an independent, high-level Policy/Program Manager (PPM), via contract, whose primary task is to develop and oversee the implementation of the policies and programs of SMCEL-JPA. The PPM shall report directly to the SMCEL-JPA Board and will work in collaboration with the Executive Council of SMCEL-JPA as well as other staff. The PPM is to provide project management services under an initial contract of two years, with an option to be extended upon satisfactory performance, of no more than four (4) one-year extensions.

On July 19, 2019, staff issued the Request for Qualification/Request for Proposal (RFQ/RFP) for the PPM to fourteen firms. Two highly qualified firms, CDM Smith and HNTB Corporation, responded by the deadline. Presentations and interviews were conducted on August 12th before a panel comprised of Policy Managers from both the Alameda County Transportation Commission and the Santa Clara Valley Transportation Authority, as well as staff from C/CAG and SMCTA. SMCEL-JPA Executive Council, Sandy Wong was also present to observe. At the end of the process the panel was unanimous in recommending HNTB Corporation as the number one choice.

HNTB Corporation is an infrastructure solution firm that has been in existence for over a 100 years. They are one of the top providers of toll services and express lanes services in the country and has operations in Northern California for the past 50 years. HNTB Corporation has assembled a team of experts to be led by Matthew Click as the Policy/Program Manager for SMCEL-JPA. Mr. Click has over 23 years experience in road pricing and has been working for express lanes for 15 years. He has worked on over 20 express lanes in nine states.

Staff has negotiated the draft agreement between SMCEL-JPA and HNTB Corporation. However, since the final negotiation has not been completed yet, it is recommended that the Executive Council be authorized to negotiate final terms prior to execution by the Chair, subject to legal counsel approval.

RESOLUTION SMCEL 19-05

RESOLUTION OF THE BOARD OF DIRECTORS OF THE SAN MATEO COUNTY EXPRESS LANES JOINT POWERS AUTHORITY (SMCEL-JPA) AUTHORIZING THE CHAIR TO EXECUTE A TWO-YEAR AGREEMENT WITH HNTB CORPORATION FOR POLICY/PROGRAM MANAGEMENT SERVICES IN A TOTAL AMOUNT NOT TO EXCEED \$1,381,716.

RESOLVED, by the Board of Directors of San Mateo County Express Lanes Joint Powers Authority (SMCEL-JPA) that,

WHEREAS, the Joint Exercise of Powers Agreement for the San Mateo County Express Lanes was approved by the City/County Association of Governments ("C/CAG") Board and the San Mateo County Transportation Authority ("SMCTA") Board at their board meetings on April 11, 2019 and May 2, 2019, respectively; and

WHEREAS, the First Amended and Restated Joint Exercise of Powers Agreement for the San Mateo County Express Lanes ("JPA Agreement") was approved by the C/CAG Board and the SMCTA Board at their respective board meetings on June 13, 2019 and July 11, 2019; and

WHEREAS, the JPA Agreement created the SMCEL-JPA to: apply to the California Transportation Commission in order to own, administer, and manage the operations of the San Mateo County Express Lanes ("Project"); to share in the ownership, administration, and management of any potential future express lanes within San Mateo County; to set forth the terms and conditions governing the management, operation, financing, and expenditure of revenues generated by express lanes in San Mateo County; and to exercise the powers as provided by law (including but not limited to California Streets and Highways Code Section 149.7, as it now exists and may hereafter be amended); and

WHEREAS, the JPA Agreement defines the individual roles and responsibilities of the partnering agencies and certain staff, including the Executive Council, County Counsel, SMCTA and C/CAG staff, and the Policy/Program Manager (PPM) to the SMCEL-JPA; and

WHEREAS, the SMCEL-JPA desires to retain Policy/Program Manager services; and

WHEREAS, through a Request for Qualification/Proposal process, HNTB Corporation is being recommended to provide said PPM services; and

WHEREAS, the term of this Agreement is for a period of two years, commencing on November 1st, 2019, with a Not to Exceed Amount of \$1,381,716, subject to SMCEL-JPA annual budget approval beyond June 30, 2020; and

Now Therefore Be It Resolved, by the Board of Directors of the SMCEL-JPA that the Chair is authorized to execute the Agreement with HNTB Corporation for Policy/Program Management Services in a total amount not to exceed \$1,381,716 for a two-year term; and further authorize the Executive Council to negotiate the final agreement prior to execution by the Chair, subject to approval by SMCEL-JPA Legal Counsel.
