INFORMATION

Samantha Soules, HNTB, provided a presentation of the upcoming agreements and actions necessary for the operation of the express lanes, and an overview of the key elements of a Toll Ordinance.

SMCEL-JPA Board members provided the following questions and comments.

- Do other Bay Area Express lanes provide equity discounts? How does the unbanked population get a transponder?
- How does the region establish its express lane standards, and how much can we differ from those standards? Will the toll policies be consistent with connected express lanes like SR 237? San Mateo County is different because of the high number of corporate shuttles and clean air vehicles. How to balance a seamless experience for drivers across different express lanes with the unique characteristics in San Mateo County?

- Can toll policies, for example the discount for clean air vehicles, be flexible and amended over time? How to balance equity concerns and the discount for clean air vehicles? The JPA Board will have to consider the policy pros and cons of the different options for maximum toll caps, including the no maximum toll cap option. How will the toll ordinance address public transit express buses and private buses?
- How much time do CHP officers dedicate to monitoring express lanes? Does the CHP have the necessary resources to enforce toll violations? Can HOV violations be removed through driving school? Are the penalties consistent in the region? Is there technology that can identify and enforce occupancy violations through cameras? Are there penalties issued via license plate readers? Will CHP enforcement of express lanes redirect CHP resources from other parts of the County?
- Will there be public outreach informing drivers of the need for a transponder before the opening?
- Is the region addressing how to accommodate autonomous vehicles in express lanes?

Samantha Soules, and other staff, provided verbal responses where possible, and noted which topics would be more fully addressed in future SMCEL-JPA Board meetings.

Drew, a Member of the Public, asked how two-seated vehicles would be treated and asked for more detail about clean air vehicles in future presentations.

BACKGROUND

<u>Year to Date Sources of Funds</u>: As of September year-to-date, the Total Sources of Funds are \$0, because there have not been advances for FY21 under the two operating loan agreements between the SMCEL-JPA, the San Mateo County Transportation Authority and the City/County Association of Governments.

<u>Year to Date Uses of Funds</u>: As of September year-to-date, the Total Uses of Funds are \$170,273. Major expenses are in Staff Support \$74,038, Administrative Overhead \$13,354, and Consultant \$81,881.

Budget Amendment:

There are no budget amendments for the month of September 2020.

Other Information:

Loan payables represent loan advance payments received since the formation of the SMCEL-JPA from the San Mateo County Transportation Authority and the City/County Association of Governments. Loan advances will be repaid on a monthly basis and no later than five years after the San Mateo County 101 Express Lanes Project begins operations and receives toll revenues.
